I teach fourth grade here. I know this is the time of year where you decide what we are and aren't having and schedules are being made. The push for technology, again, for the Middle School for next year. Most of everyone is incorporating technology in our classrooms. But, because I teach ELA (spelling, English, writing), I do not have time to teach the kids how to use the technology. So if we cut the technology program at the Middle School, it won't be done. This is the second year we've had technology. The first year, last year, was pretty good. When I do these biography projects. I see a couple of kids who I had that did it when I had them in fourth grade, everything was done on paper and pencil. I thought it was really great when we started doing it on PowerPoint and now on Google Slides. Mr. Giesy has incorporated so much, these kids are on the ball. Today I gave them the outline to fill out and they're like, "Wow! But do we have to do it on paper, or can we do it on Google Slides and send it to you? Or can we do it on Google Docs and send it to you?". This way, we are hitting all the students. We are hitting all students' abilities, those that have difficulties with writing. Obviously, I surveyed my students yesterday. Less than half have actual technology that they can use in their home. High school may be better, but at the elementary level, we are expecting them to do Lexia, we are expecting them to do the state tests. And we are putting our kids who are already, some of them, farther behind because they come to school not ready. We are just adding to their problems. And, actually, people aren't going to move here. People aren't. If you aren't going to offer technology at the lower levels, they're not coming. Not the young, educated people that you want, that have money, that are actually going to buy a home. They aren't going to move here unless we offer technology. So that's my plea.
