We came up with the idea of "Buy a Brick" to help raise money to resurface the track. We think it would be a good idea to lay brick around the 400 meter sign and get rid of the river rock that is there. Jason Dickey is doing all the labor for free. That's the first area we want to do, and I would like to have it approved as soon as possible because our fish fry starts March 3<sup>rd</sup> and we want to start advertising it at the fish fry. We are only going to run it this year from March until the middle of June. Then we will ship it away and get our bricks, and get them put in around August. We will buy bags of hot patch to put in because we aren't going to sell enough bricks in the first year. Next year we want to run it again from November to June. We should definitely have enough bricks by then to do it all. We would like to start it now.

Mrs. Koontz asked how much the bricks will cost. Mr. Crum said that we are selling them for \$75 per brick.

We are going to area businesses for the 8 X 8 bricks. They will sell for \$200-\$300 each. I would have to look at the paperwork on it. The next project where we would want to put bricks would be around the flag pole. The American Legion would buy and 8 X 8 brick. We would put it around the flag pole with some little bricks. Our main concern is the big area first.

Mrs. Koontz asked why the price changed from \$50 to \$75. Mr. Crum said that they wanted to raise more money to help with the track, and do other things around the stadium like eventually resealing the blacktop under the bleachers. We want to do improvements around our school for sports and stuff.

That's all I'm asking. Can we get it approved? I have two weeks. That's all.

Then we would ship the order away and get it back by the end of July so Mr. Dickey can start installing the bricks as soon as we get them.

Mr. Baker recognized the students attending the board meeting. They were attending for Boy Scouts. Mrs. Davis thanked Mr. Baker for recognizing the students and welcomed them to the meeting. They appreciate the Boy Scouts.

Legislative Liaison - Mrs. Debra Davis

Lots of things are going on. The budget bill is still in limbo. Besides money, portions of the budget bill that concern us include valuations for properties, transportation changes, career tech changes, third grade reading, teacher tenure, and college credit plus. There are a lot of things that we are going to be hearing about in the coming months.

Mrs. Koontz asked if this was the bill that would require teachers to work with businesses during the summer to renew their licenses. Mrs. Meeks said that yes that is part of the budget bill.

Mr. Woodard said that there is also a part about adding three board members. Mrs. Meeks said she would review that later in the meeting.

Finance Committee - Mr. Brent Powell and Mr. Kenneth Kline

Mrs. Meeks reviewed a few points in the budget bill that would affect the District. Her points included the Superintendent appointing three nonvoting members to the Board who represent local businesses, changes in the transportation funding formula, and requiring the teachers to work an externship with area businesses in order to renew their licenses.

The externship really bothers Mrs. Koontz. She feels it devalues teachers, and they won't gain anything from it.

Mr. Powell said that he believes they are trying to make a connection between public schools, career centers, and the business world to help students get jobs when they graduate high school.

Mr. Baker believes that most teachers have worked outside the school district, and they do have experience in the work force. It's a philosophical issue. Why are the schools here? Is it to provide labor, or to instruct students on being participatory citizens, and having a basis of knowledge for their future lives? It seems to me that they are stressing more of the vocational aspect than the educational aspect.

Mrs. Meeks distributed an article about contacting the legislators to voice your opinion about the board member issue and the externship for teachers. It discusses OSBA's perspective about the situation.

Mrs. Meeks reviewed the circumstances of our state funding this year. Our state funding has decreased by \$331,377 since the forecast was prepared. Therefore, the state budget bill is based on our decreased funding amount versus the amount we were receiving when the forecast was prepared at the beginning of the school year. This means that the state budget would negatively affect our five year forecast even though it provides for a \$22,123 decrease in FY18 and a \$101,567 increase in FY19. It would cut our ending balance next year to \$261,608. Mrs. Meeks is going to review our state funding with the Board on a monthly basis in the future.

This year we had sixty seven-students who attended the Career Day for Newton Falls. You never know how many will actually go to the school. They just go to see if they would like the programs.

Also, I was able to attend the breakfast for Student of the Month for January. It's very nice to be able to go. I got to meet Cassidy Hastings in the auto collision program. She was nominated by her teacher, Mr. Hess. I was able to sit with her parents and had a really nice time. When Mr. Hess was sharing a story about Cassidy, he said that she volunteered for nine months at Greenwood painting cars so she could learn it. They final hired her. She also had another job during the time she was volunteering. It's neat to meet these students. It was really nice. Congratulations to Cassidy Hastings.

Also, Katelyn Nolton got first place for writing. She will be heading to Columbus on April 19<sup>th</sup> and 20<sup>th</sup> for another competition.

TCTC is going to add a couple new programs. One program is nail technician. Once they get done with the program, they go right to work. Another program that is going to be added is HVACR. It stands for heating, ventilation, air conditioning, and refrigeration. There is a need because people are retiring from this field and they don't have new people to replace them. They can start out making \$18 to \$20 per hour and average annual wage for people going into programs is \$43,000 to \$65,000 a year.

Right now at TCTC, we have fifty three students enrolled. That was as of January 27<sup>th</sup>. We pay \$4,782.35 per student.

On February 9<sup>th</sup>, TCTC was recognized as a top performing school in northeast Ohio. They received a banner for their achievement.
