Resolution to Proceed With the Submission of the Levy

BE IT RESOLVED, that upon the recommendation of the Treasurer of Schools, the Newton Falls Board of Education approve the following motion:

WHEREAS, on December 10, 2014, the Board adopted a resolution requesting the Trumbull County Auditor for a calculation of the millage necessary to raise a specific number of dollars for the renewal of an existing levy pursuant to O.R.C. §5705.195, as described below, a copy of which was certified to the Trumbull County Auditor; and

WHEREAS, the Trumbull County Auditor has certified to the Board that the annual tax levy required throughout the life of the proposed levy to produce the annual amount of Five Hundred Eighty-Five Thousand Eleven and 00/100 Dollars (\$585,011.00), as set forth in that resolution, calculated in the manner provided by O.R.C. §5705.195, is 4.55 mills for each one dollar of valuation, which is forty-five and one-half cents (\$0.455) for each one hundred dollars of valuation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Newton Falls Exempted Village School District, Trumbull County, Ohio, a majority of all members of the Board concurring that:

Section 1. The Board desires and determines to proceed with the submission to the electors of the District at the election to be held on May 5, 2015 the question of levying a renewal of an existing levy, pursuant to O.R.C. §5705.195, in excess of the ten-mill limitation for a period of five (5) years, commencing with a levy on the tax list and duplicate for the year 2016 to be first distributed to the Board in the year 2017, to raise the amount of Five Hundred Eighty-Five Thousand Eleven and 00/100 Dollars (\$585,011.00) each year for a period of five (5) years for the purpose of providing for the emergency requirements of the District, at the annual tax rate necessary to raise that amount, which rate is estimated by the Trumbull County Auditor to be 4.55 mills for each one dollar of valuation, which is forty-five and one-half cents (\$0.455) for each one hundred dollars of valuation.

<u>Section 2</u>. The Treasurer is authorized and directed to certify immediately a copy of this resolution, along with the Board resolution and Auditor certificate referenced in the preamble, to the Trumbull County Board of Elections and request that the Board of Elections prepare the ballots and make other necessary arrangements for the submission of this question to the electors of the District, all in accordance with law.

<u>Section 3</u>. It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with law.
