Melissa Shuttic, Elementary Teacher, residing at 118 Dennis Drive, Cortland, OH 44410

I understand that we are possibly cutting teachers to three per grade in the elementary. The third grade reading guarantee will be very difficult under these circumstances. We won't be able to meet all the needs of the students with these larger class sizes.

Christine Stinson, Concerned parent of two First Graders, residing at 253 Arlington Boulevard, Newton Falls, OH 44444

I love Newton Falls Schools. My kids' class size is now nineteen. We already have two to five kids that have behavioral issues or learning issues. I fear my kids will fall through the cracks. Fifteen parents were supposed to be here, and will attend next month. All buildings will pay the price for large class sizes.

Jessica Rader, Elementary Teacher, residing at 3704 Newton-Tomlinson Road, Warren, OH 44481 (Newton Township)

We're getting together with ideas to keep class sizes small. The school has hired people we don't believe needed to be hired. We feel guidance and secretaries can do the work.

Sue Thompson, Fourth Grade Teacher, residing at 5923 Pat-Ann Drive, Warren, OH 44481

Class size is a big issue. It is very hard for intervention, value added, and district ratings. If I move out of fourth grade, there won't be any materials because I purchased them all myself. We will have to buy additional materials. We need to look elsewhere instead of cutting the legs of the tables. Teachers should be the last to be cut. We're cutting art and that's why most kids come to school. Hopefully, we can work together to come up with an alternative.

Tim Stinson, Concerned parent of two First Graders with two younger children, residing at 253 Arlington Boulevard, Newton Falls, OH 44444

I don't think cutting teachers is the way to go. I would much rather see pay to play. How will lunches and recess be covered? We have higher student ratios now than most in the area. (approximately thirty per class) I only found one higher. Paying for sports is a much better option.

Megan Perrine, Fifth Grade Teacher, residing at 449 LeMae Street, Newton Falls, OH 44444

The elementary needs the most focus on reading and math, and getting the basics. Many students don't qualify for special education, but they're not at grade level. I would like to see more concentration at the elementary level because they don't have the basics when they come to the junior high.

Paul Woodard, Superintendent

None of these decisions are easy. We are deficit spending. We have lost \$1,250,000 in funding since 2009. We have lost \$3,000,000 to charter schools since 2004, and our enrollment is decreasing. We made \$600,000 in cuts last year. Many of those cuts were through attrition and budgetary cutting measures. We also eliminated technology positions, French, and general music. We have to make cuts and pass a levy. I have lived through this already at Waterloo. Thirty kids in a class is a little misleading. Most classes are in the twenties. People around us had pay and step freezes, and lost employees. They can't bring anyone back because it snowballs. This is where we are now.

Pay to play is being discussed and will happen soon. When cutting minor sports, you lose more in funding than the program costs if students leave seeking sports. We are also looking at school fees as well. Students on free and reduced lunches do not have to pay. We estimate that we will bring in approximately \$60,000 with school fees and pay to play.

The theme since I started here has centered on drug issues, bullying & harassing, truancy, and attendance. I thought and prayed about it, and decided to hire a community liaison. Our community liaison has met with over three hundred students in our district this year, and is working to create a school-community atmosphere. Her salary is paid for from a grant, not our general fund. When she worked at the Trumbull County ESC, she only saw five to six of our students throughout the year. I am trying to be out in the buildings. I have had students and parents in my office crying because they have parents or kids addicted to drugs and alcohol.

I am not a dictator. I approached both unions and asked them to take a look at what we're discussing. I didn't just say that this is what we're doing. We are fighting the Governor's desire to eliminate smaller schools. I am trying to gain trust and bring everyone together. I want this school to stay intact.

I would like to see four teachers per grade level. We had to submit a letter to the State to prevent the State from coming in and taking over. I am going to fight until the last second, and we will

work to try to save jobs if we can, but the union has to work with us as well. If we don't pass a levy, and we don't get concessions, we will be right back here in one year.

We have to work together to keep this from happening. I am also worried about the third grade reading guarantee. We have to come up with "X" amount of dollars. Administrators are on pay freezes as well. Those who were recently hired were told that there would be no pay raises in the near future.

I did get a \$1,000 pay increase for this year. I came in making less than my predecessor. \$1,000 is a lot less than at step increase for teachers. I will take a pay freeze for the next five years if everyone else does as well.

Brenda Koontz, Board Member

The Community Liaison does much more than shuffle paper and make phone calls. She is really helping our kids get their acts together, and she is meeting with parents frequently.

Paul Woodard, Superintendent

I did tell Carey Anderson when I hired her that if the grant money goes away, she would not have a job.
