5 Year Forecast

Earlier in the week Dawn updated the Board of Education letting them know that not much has changed. Insurance meeting earlier in the week and we are looking at double digit insurance rate increases. Insurance consortiums around us have been having increases for some time now. We have been fortunate to not have an increase in six years. Within the 5 year forecast, 7.5% increased insurance rates in January and 7.5% increased insurance rates July were put into every year of the forecast from 2018 out. It blows the forecast up. Unrestricted grants and aides, basic foundation, is based off of the first October payment. The insurance adjustments have thrown us into the red by 2020. Dental and vision insurance don't increase nearly as much as health insurance. We have been fortunate our consortium has protected us for this long from insurance rate increases. Paul went to the insurance meeting and found out that the change in prescription plan will save them quite a bit of money. If they wouldn't have changed the prescription plan, rates would have rose to 22%. Paul went on to say we might have to look at some ideas like taking the Elementary School offline and RIFs across both unions.
