Superintendent's Reports and Recommendations

A. Reports

Our ALICE training meeting was last night. We had 30 to 40 community members attend. The police did a similar presentation that they did for our staff. Now police will come in and begin educating the kids on evacuation procedures, how to barricade rooms, and how to react if a shooter comes in their room. This training will vary by age level. This training will begin in the next few weeks. We will then practice evacuation procedures and talk to kids about keeping lockers and doors closed at all times. Students will be instructed to flee to Shopko, or to barricade themselves in a room depending on the situation. In the event of an active shooter situation, the town would be virtually shut down with police and buses.

We also need to develop a plan to get the students back to their parents. This is a long and tedious process. It could take six or eight hours. In light of that, rooms will be equipped with "go to" buckets of supplies to help the students and staff members who have to be locked down for hours at a time. Our staff training really opened our eyes to the reality of these situations, and we plan to take it very seriously.

I checked on the Pledge of Allegiance. The elementary and middle schools say the Pledge daily. The elementary said the Pledge over the PA system recently, and decided they are going to try it that way versus in the rooms at different times. The high school hasn't had the Pledge for ten years. Mr. Crowder is willing to have something on the television with the morning announcements if the Board so desires.

We have had a lot of tech issues since school started. We believe we were struck by lightning over the summer, and we are working to resolve those issues.

I would like to include a request from the Little Tigers for additional days on the field in our facility use resolution if it is okay with the Board.

The golf team won the league tournament last Monday, and they are now in sectional play. We actually dropped a division because of our decrease in enrollment. We will be awarding them Tiger Paws at a later date.

The elementary has decided to bring back Halloween dress-up this year to see how it goes. We have a different blend of students this year, and thought we would give it a try. There will not be a Harvest Festival, but there will be some type of Winter Festival.

I am interested in attending a leadership institute for superintendents in Columbus. There was a cancellation that would allow me to participate, but I have to let them know by tomorrow. It is all paid for by BASA except for mileage. The institute would require four evening appointments with two days of training. Fellow superintendents say that it is a very valuable program, and an excellent opportunity.

I also need a brief executive session to discuss negotiations and discipline.

The Board decided to reinstitute the Pledge of Allegiance at the high school, and to allow the Superintendent to attend the leadership institute in Columbus.
